Self-catering

St Martin's College is a self-catered Residential College so come prepared to do your own cooking. Before you arrive, it is helpful to know how to make 6 or 8 meals (at least) so that you can maintain a balanced diet while living away from home.

We have a new Foodworks grocery store in Estella about 2kms away from the College. Woolworths, Aldi and Coles are about 10 kms away "in town". Cottage residents sometimes make a community outing of a trip to the supermarket. If you have a car and your neighbour doesn't, invite them to join you when you go to buy groceries.

Organising for some shared purchases of shared items works well in some cottages. For example, you might all contribute \$10 at the beginning of Term to buy dishwashing liquid, laundry detergent, dish cloths and other similar items that everyone can share.

Self-catering also means cleaning up after yourself, so don't leave a mess in the kitchen for other residents to clean up. Wash up, wipe down the benches, keep the cook top clean and put away your cooking utensils after each meal. Don't be that person everyone is annoyed with because "they don't clean up after themselves." Don't leave unwashed dishes in the sink or on the benches.

Allocation of Accommodation

The normal practice at the start of an academic year is to have a mix of new and continuing residents in each cottage. Allocation of rooms seeks to maintain, as far as is reasonably possible, a mix of occupants on the basis of year of study, gender, discipline of study and country of origin.

The College reserves the right, with 7 days' notice in writing, to move students to another room in the College should the need arise, for repair or maintenance, to avoid difficulties between residents, or to ensure the good running of the College.

Students in residence are expected to live and work harmoniously with others in their cottage, maintaining the common areas in a way that reflects healthy community living. Residents need to do their own washing up, clean up the kitchen after they have used it and respect things that belong to others. If tension in a cottage does arise and resolving issues internally proves to be difficult, it is often helpful to seek assistance from an RA or the Head of College.

What is in my cottage?

The College has 12 "cottages" of eight bedrooms with bathrooms & other amenities. Cottages have secure access using your CSU Student Card.

Each bedroom has its own room key and an individually controlled reverse cycle air conditioner for heating and cooling. Each bedroom is equipped with a bed, wardrobe, desk, chair, small refrigerator, rubbish bin and wireless internet.

All cottages have a kitchen and common room with lounges and TV. The kitchen has a convection microwave oven, a cook-top, kettle and toaster. Each cottage has a chest freezer, iron and ironing board for students to share. Each resident has a food storage cupboard in the kitchen.

Cottages have a washing machine, clothes dryer & clothes lines for the use of St Martin's students only.

What do I need to bring with me?

Residents need to provide their own king single bed mattress protector, king single bed sheets, pillow and pillowslip, doona and doona cover, bath towel/s, crockery, cutlery, cooking utensils, tea towels, first aid supplies, desk lamp *etc*. For students who arrive at College without kitchen equipment, we can provide them with a kitchen starter pack to tide them over for a short while until items are purchased. Please let the office staff know if you wish to access a "Marties' Starter Pack".

Your personal electrical equipment

Any electrical items you wish to use in the College including frypans, grills, hair straighteners, computers, printers, *etc* must be tested and tagged. The College will organise for this to be done at the beginning of Term 1. Double adapters, fan heaters & bar heaters are not allowed in the College.

Length of stay at St Martin's College

We expect you to stay at College for a minimum of the length of time of your initial contract. Residents of St Martin's College may stay in the College for the full length of their undergraduate and/or postgraduate studies, as long as they abide by all College rules.

Students are not necessarily guaranteed the same room in the College from year to year, and room allocations are at the discretion of the Head of College.

Returning residents receive a loyalty discount rate for room contracts and are not expected to go through a formal re-application process. We communicate with current residents towards the end of each year to ascertain whether or not they will be remaining at the college for the following year.

Room Inventory

When you move in you will receive a room inventory form. This is a legal document and must be completed and signed and returned to the College Staff **within 24 hours of arrival**. You will be charged for items damaged or missing from your Room Inventory when you vacate your room. No college furniture or bedding may be removed from rooms or cottages <u>at any time without permission</u> of Head of College. Furniture from areas intended for general use is not to be taken into students' rooms and must not be taken outside the cottage.

Room Key

You are responsible for the room key that is issued to you. It must be returned at the end of your contract to the Key Return box in the Fairfax building foyer. There is a charge of \$30 if you lose or do not return the key. <u>You are not permitted to have additional keys cut.</u>

Room and Cottage Cleanliness

Student rooms and common areas must be kept tidy to enable cleaning staff to do their jobs effectively. This is as much about courtesy as it is about cleanliness and hygiene.

It is the responsibility of each resident to make their bed, clear rubbish and maintain the cleanliness of refrigerators. All spills are to be cleaned immediately. All waste is to be put in laundry rubbish bins. **Cooking in bedrooms is prohibited.** Kitchen benches are to be kept clean. Please do not put hot pans directly onto the laminate benchtops.

Cleaners are not expected to vacuum bedrooms that are not cleared of personal belongings from the floor. Nor are they expected to clean kitchens that are in an unacceptable condition.

Personal items are not to be left in Common rooms, bathrooms, hallways or in areas of the kitchen that prevent other students from preparing meals.

Laundry sinks are not to be used for washing up, soaking dishes or to store kitchen utensils. No fat is to be poured down sinks. No washing is to be left in laundry sinks. Bathroom sinks are not to be used to wash laundry.

No horse blankets or riding gear are to be washed in college machines – please use the machines at the CSU stables.

If the cleaner cannot clean a room, this will be reported to the Head of College. Any student whose room is in an unacceptable condition will be given forty-eight (48) hours to return the room to an acceptable condition. If the room remains in an unacceptable condition the resident will be fined \$50. The resident will have fourteen (14) days to pay the fine. If payment is not made by the due date the amount will double to \$100, with fourteen (14) days to pay.

Any resident who fails to keep their room in an acceptable condition on a regular basis may be asked to vacate their room.

Cooking and eating utensils must be washed and put away the same day they are used. Leaving dirty dishes and cooking equipment, left-over food and crumbs out in the kitchen is unhygienic and can attract cockroaches, ants and mice, and can cause food poisoning.

Attaching posters to the walls

Please use blu-tac to fix posters or any other items to walls – all blu-tac must be removed at the end of the year. Do NOT use glue, double-sided tape or nails. Do not put stickers on any of the furniture or fittings of the College.

Can I take College property away with me for a weekend?

College property is not to be taken out of the College without permission from the Head of College.

The Oak on my door

Oaks are part of an established College tradition and are a way to communicate if you wish to have privacy. They are to be used with respect. If a person has their oak hanging on the outside of their door no student may knock, phone or disturb that student. The only people who may do so are the Head of College or RAs in an emergency. An oak may not be used to avoid having your room cleaned and may only be hung on the outside of your door if you are actually in your room. When students leave the College or move into a new room, they are invited to write their name, years of residence in St Martin's College, and Course studied on their oak. Continuously having the oak on the outside of the door will generally result in a pastoral conversation with a Residential Advisor or the Head of College.

Car parking

There are many car parking areas located around the campus which are all free to use. The carpark nearest to St Martin's is located near the entrance to the college, along Dargin Way.

Can I have guests visit me from outside the College?

Yes - you can have people visit you in your cottage.

Your friends can visit during the day or the evening as long as you are not disturbing your neighbours. Guests must follow College rules and be respectful of other residents. You are responsible for the behaviour of your guests and you will be charged if college property is damaged.

Friends or family staying overnight need to be approved in advance by the Head of College and will be charged a fee of \$15 (we can supply a mattress and linen for someone to sleep on the floor of your bedroom). Please email the Head of College <u>48</u> <u>business hours in advance</u> of your guest arriving to obtain permission for them to stay.

If the guest is a family member or friend and you would like them to have a room of their own this may be possible depending on the occupancy rate of the College at the time of their arrival. They will be charged \$60 per night with linen and towels provided.

During term time we do not generally allow overnight guests to stay in a shared cottage for more than three consecutive nights. Guest requests during exam periods are not permitted.

Summer storage of personal items

There are two options for summer storage.

- 1. You can keep your belongings in your room at the current Summer Storage contract rate, enabling you to return to the same room the following year having kept your belongings in the room.
- 2. You can store boxes of belongings for free in the locked storage rooms at the back of most cottages.

No food or perishable items are to be stored in either location over the summer and all kitchen items must be clean and dry so as not to attract vermin.

To be eligible for either of the summer storage options you must be returning to St Martin's the following year, failure to return will incur additional storage costs.

The Fairfax Centre

The Fairfax Centre is a community area located at the centre of the college. The Fairfax Centre provides spaces for recreation and study - it is equipped with a table tennis table, a pool table and a piano. There is a study common room with computers, a photocopier, an area for small group discussion, a fully equipped kitchen with oven, and a BBQ area outside. It is also where you will find the staff offices.

The Chapel

The St Marys Chapel offers space for worship and quiet reflection. The on campus Christian Fellowship (UniChurch) sometimes host a weekly Bible study that all residents are welcome to attend.

Community Garden

There is a student vegetable and herb garden located near the Walla Walk between cottages 465 and 469. This is available for shared community use. Speak to the Head of College if you are interested in the community garden.



Community Sport

St Martin's has teams in the inter-college weekly sports competition. We prioritise participation but it is extra fun when we also win.





Maintenance requests

Please report any maintenance issues as soon as possible by contacting the College office <u>stmartins@csu.edu.au</u>. We have maintenance staff who come in each week to undertake basic maintenance. Specialist tasks (plumbing and electrical etc) are done by external contractors as quickly as possible after a report is received.

Room Lockouts

If you are locked out of your room during the day or before 10pm, contact either the College office - Ph: 6933 4966 (office hours) or the RA on Duty - Ph: 0483 828 036 (after hours). After 10pm please contact Campus Security - Ph: 1800 931 633.

What if the fire alarm goes off?

Whenever you hear the fire alarm going off in your cottage you need to act as if the building is really on fire and get yourself and others out of the cottage as quickly as possible.

Most often though, fire alarms go off because people are inattentive when cooking and smoke (not fire) sets off the alarm. Turn off whatever is cooking, put a lid on the saucepan to reduce the amount of smoke or turn off the toaster at the wall. Open some doors and windows to allow the smoke to clear.

Call CSU Security – Ph. 1800 931 633 - these are the only people (apart from the fire brigade) who can turn off the alarm. Tell them which building you are in, and they will come and assist you.

If there is an actual fire you must still call CSU Security because they will meet the fire brigade and escort them the shortest way to the correct building. After you have rung CSU Security ring the RA on Duty to let them know that a fire alarm is going off and that Security are on their way – RA Ph. 0483 828 036

Resident safety is our most important priority so ensure you and anyone else in the cottage get out and are accounted for as soon as possible as you wait for Security and the Fire Brigade.

At least once every year we have a fire drill to practise evacuation of cottages and other spaces, and to identify safety zones.

I'm concerned about someone else's welfare - what do I do?

Your first point of contact is generally with the Resident Advisor on Duty (Ph: 0483 828 036) or with the office if it is open. The staff member will be able to help you work out what the best course of action is given the specific circumstances you are describing. This may involve contacting the Head of College, ringing for help from CSU Security or getting in touch with emergency services if that is required.

Please don't hesitate to reach out if you need help or support from an RA or the Head of College as resident safety is our most important priority!

Be a good friend and neighbour and get help for your mates. Don't leave people in dangerous situations at a party if they are drunk. Help them get home safely. Caring for others in the community is one of the things that sets St Martin's residents apart from the crowds.

St Martin's Annual College Awards

The St Martin's College Dux

The recipient will have their name recorded on an Honour Board and receive a \$200 bursary sponsored by the Australian Bedding Company. The College Dux is awarded to the student who has the highest grade point average in the three semesters prior to the Annual Dinner and whose personal character reflects the ethos of St Martin's College in their day to day life.

The Cottage of the Year

A plaque and \$200 is awarded annually to the cottage that wins "Cottage of the Year". The winning cottage's selection is based on - active participation in college community activities, engagement in enhancing college life, and keeping the cottage and its surrounds clean and tidy. RAs keep a point



tally during the year and the award is made in time for the cottage to celebrate before the academic year ends.

Charles Houen Citizenship Award

This award is named after Charles Houen who was a keen supporter of St Martin's College for many years and a very active citizen in the Wagga Wagga community. He was part of St John's Anglican Church, a member of Rotary for many years, an alderman on the city council and a well-respected local lawyer. He displayed exemplary citizenship in his community over many years. The winner of the Citizenship award receives \$200 and their name goes on an honour board in the foyer. Current members of the RA team are not eligible to receive this award.

Marie Thompson Award for Excellence (may not be awarded annually)

When Marie Thompson was awarded an Honorary Master of Education degree in a ceremony at CSU in the year 2000 that "no one outside the official education system has had a greater impact on education in Wagga Wagga and the Riverina." She is acknowledged not only for her amazing contribution to education but also for her tireless efforts for the community. It is said that Marie epitomises what is best in community participation and selfless commitment. As part of her wider community involvement, she was a member of the St Martin's College Board. Recipients of this award must have considerable community involvement outside the College and demonstrate excellence in at least one discipline (academic, sport, leadership etc) at a State, National or International level.

Payment of Fees

Fee payments can be made:

- Using direct deposit into the College account, or
- By credit card at the St Martin's College office, or
- Over the phone call 02 6933 4966.

Fees can be paid in an annual lump sum payment for the whole year; in four quarterly instalments paid each term; or as a fortnightly payment. How you pay can be decided at the beginning of each year.

Please note that you are responsible for the fees for the entire contract period and there is a charge for breaking your contract early. Please read your contract and ask any questions you have before signing it.

If you are having difficulty paying your fees

If you begin to have difficulty paying your fees, please inform the Head of College as soon as possible. It is much better to discuss the situation early than get into financial difficulties.

CSU has staff who can offer some financial advice to students. Many of our residents are eligible to apply for various Centrelink payments aimed at university students, so ensure you have explored your eligibility for these if you have not already done so.

Failure to pay room fees will result in the student being requested to vacate their room. See the Debt Collection Policy on our website for more details.

What is the refundable security deposit?

The \$500 Refundable Security Deposit is paid before your arrival. We hold this money throughout the time you have a room contract at St Martin's and it is refunded when you move out permanently. Deductions may be made for damage caused by you or your guests to your room or other College property, or if there are any college items missing from the room – this includes the office chair and privacy oak.

Fee for Break of Contract

When you sign the accommodation contract you are entering into a legally binding arrangement that sees you liable for payment of fees for the entire contract period. It is expected that students who apply for residence in St Martin's College will stay in residence for the entire length of their contract. Students who choose to leave before the end of the contract are required to give at least two week's notice in writing, and will also be required to pay a Break of Contract Early Fee of \$500. There may be some additional charges depending on the circumstances of the departure, the notice period given and how long it takes for us to fill the room left vacant. They will also forfeit their Refundable Security Deposit.

The College office (front desk) is open Monday to Friday from 9.00am to 1.00pm to assist students. Located in the Fairfax Centre, it deals with the financial & office management of the College.

The Head of College, Susan Bazzana, is responsible for the operation of the College, its administration, management and pastoral care of students. Susan works full time and



will often be available in her office after the front office has closed. She lives on site in Building 463 and during the year often invites small groups of residents over for meals. sbazzana@csu.edu.au Ph 02 6933 4852 Ph 0483 838 742

Assistants to the Head of College

Pippa Prenzler, Beck Lance and Anna Conyers are responsible for the office administration and will be able to assist residents with many day-to-day

The College Cleaners are responsible for

cleaning the student residences. If you have complaints about cleaning, please let the office know.

The RAs or Residential Advisors are long term residents of St Martin's who assist in pastoral care and have current first aid training. These Senior Students take on special responsibility for Academic, Sporting, Christian, and Social development programs. The positions are advertised at the end of Term 3 of each year. Training is undertaken in February each year. They are your first point of call in an Emergency and share "duty" across the week. **Phone 0483 828 036 to contact the RA on duty.**

GPs are located close-by in Estella & other parts of Wagga Wagga. You will need a current Medicare card.

Mini-Mart and Post Office Agency

"Charlie's" is a small shop and post office within walking distance of the College which has bank & post office facilities. Milk, bread, snacks, soft drinks, frozen goods and a small range of groceries, along with CSU-branded apparel can be purchased here. There is a Foodworks supermarket in Estella with a much wider selection of grocery items.

Photocopying, Laminating and Binding

A photocopier is maintained for the use of St Martin's College residents and is also available for scanning to email. Student computers are also provided in the Study Common and are linked to the photocopier for students' printing needs. A Laminating machine and a comb-binding machine are also available from the office

Security, Campus Watch

University Security Officers patrol the campus buildings and grounds every night and weekend. If you are concerned about your safety or there is an emergency, please contact **Security on 1800 931 633**.

To ring for outside emergency services dial 000, then call CSU Security. Please report any incidents to the Head of College. Emergency Services may need help to find College buildings. If incidents occur after hours, RAs can be contacted - Ph 0428 828 036, or the Head of College (in case of lockouts and emergencies) Ph 0400 919 989.

Students are required to advise the College Office of any changes to their contact details including their personal mobile phone numbers and email addresses. Students may also register with CSU Safe by texting "Wagga Wagga" to 0409 513 136 to get the campus security app for their phone.

Sporting Facilities

All Charles Sturt University students have free access to the University's sporting facilities. There is a gymnasium, squash courts, swimming pool, tennis courts, and football field within a short walking distance from the College.

Student Services

CSU student services include careers advice, chaplaincy services, counselling, disability support, financial advice and student loans, international student support, and learning and study skills.

Breaches of the following rules and regulations will incur disciplinary action.

Alcohol

Excessive use or abuse of alcohol will not be tolerated. The Head of College retains the right to determine what constitutes excessive use or abuse of alcohol. Intoxication will not be accepted as a defence against anti-social or unacceptable behaviour. Gatherings or parties where excessive amounts of alcohol are consumed are prohibited: no kegs are allowed, the making or provision of punch or bulk "goon" is prohibited, beer bongs are prohibited and any event promoting alcohol consumption as the primary activity is prohibited. Please note that CSU regulations specify that the Residential area is a "**Dry Campus**" during O week, exam weeks and for St Martin's College during mid-session exams. A Dry Campus means that no alcohol is to be consumed in residences and no parties are allowed at these times.

Permission for Parties

Students wishing to gain permission to host a party or event must submit a written application outlining the nature of the function to the Head of College.

Behaviour

It is important that all people feel safe and are allowed to occupy their own space. Residents must only enter other residents' rooms when invited.

Residents are expected to behave in a way that is respectful of other residents, staff and visitors. Students will be cautioned and disciplined for any anti-social behaviour and/or behaviour that affects the health and safety of residents, visitors, and/or staff.

Anti-social behaviour is behaviour which might reasonably be considered to cause offence and/or infringe on the rights of others. Such behaviour is not acceptable. If such behaviour persists or seriously imposes on another's health and safety or infringes on the rights of others, the person responsible will be directed to seek alternative accommodation or will not be re-admitted to the College in the following year/s.

Damages

Residents must inform the College Staff when College property is damaged. The resident/s responsible for the damage must pay for the repair. Any damage to a cottage will be paid for by all cottage residents if the person who caused the damage cannot be identified. Students will have 14 days to pay these costs.

Candles

Candles and incense are a fire hazard and therefore are **<u>absolutely banned</u>**. All naked flames are banned except for the gas stove in the kitchen.

Room Occupancy

Rooms are single occupancy only. Please see **Guests** below for information about friends and family staying with you. Guests are not permitted to stay for extended periods of time.

Dangerous Items

Guns, firearms, live ammunition, fireworks, or weapons of any sort are **<u>STRICTLY</u>** not **permitted** in the College or on campus. The Head of College retains the right to decide

what is considered a dangerous item. Breaches of this regulation will be dealt with by Charles Sturt University in accordance with their policies/procedures.

Drugs

Any cultivation, distribution or use of illegal drugs is prohibited in the College, College grounds and on the University campus. Breaches of this rule will be referred to the Police and will result in automatic expulsion.

Electrical Appliances

All appliances must comply with Australian electrical standards and be "Tested and Tagged" annually. Power points should not be overloaded in the bedrooms. Do not use double adaptors. Power boards with a safety cut-out switch may be used. No bar heaters or fan heaters are allowed. Washing machines & clothes dryers may not be used at the same time.

Guests

Your friends can visit during the day or the evening as long as you are not disturbing your neighbours. Guests must follow College rules and be respectful of other residents. You are responsible for the behaviour of your guests and you will be charged for any damage they may do to college property.

Friends or family staying overnight need to be approved in advance by the Head of College and will be charged a small fee of \$15 (we can supply a mattress and linen for someone to sleep on the floor of your bedroom). Please email the Head of College <u>48</u> <u>business hours in advance</u> of your guest arriving to obtain permission for them to stay.

Harassment, Violence

Harassment, threats or acts of violence, verbal or physical abuse are absolutely not tolerated nor condoned. Residents are encouraged to report any such incidents to a member of College Staff or staff from Student Services. Incidents will generally be reported to the Police. See the CSU Harassment and Bullying Prevent Policy

Insurance

The College does not accept responsibility for any loss or damage to your personal property. Therefore, you are advised to take out private All-Risk Insurance on your possessions.

Motor Vehicles, Bicycles and Parking

Cars are to be parked in the residential parking located below the College. Driving or parking of vehicles on the grounds of the College is prohibited, including the areas around all Cottages, the Fairfax Centre and the Chapel. This is to protect and prevent damage to the grounds, provide access for maintenance vehicles, and to ensure the safety of pedestrians. An exception is when students are loading and unloading cars – this is allowed at the start and end of terms. Vehicles must be moved and parked in the car park as soon as the loading/unloading is complete.

Bicycles are not permitted inside cottages and should be stored in the racks provided. For extenuating circumstances permission must first be sought from and approved by the Head of College.

Students must not drive on the CSU campus in a manner that is careless, erratic, or endangers people or property. Breaches of this regulation will be disciplined, and students may be issued fines by Charles Sturt University Security staff.

Noise

Noise is to be kept to a level that avoids disturbing other people. Residents and their visitors are required to keep noise to a minimum between **10pm and 8am**. It is particularly important to limit noise during assessment and exam periods. Bedroom doors must be kept closed if music is being played so as not to disturb other students. If you like it loud, please use headphones!! Always consider the needs of others and behave accordingly.

Occupancy

Each room is allocated to a specific student. An allocated student is never permitted to sub-let or allow their room to be used by another person. No room change may occur unless organised in advance in consultation with the Head of College. People found occupying a room without permission will immediately be escorted from the College site. In this case the student allocated to that room will be fined \$100. If an unregistered guest is occupying an empty room in a cottage all residents of the cottage will be charged \$100.

Pets

The CSU policy is - No animals – therefore no dogs, cats, birds, fish, reptiles or other pets are permitted in the Cottages, in any CSU student residences or in the vicinity of residences. Guide dogs will be permitted but are subject to approval by CSU's Student Services Disability Office and the Director of CSU Residence Life (see Head of College for requests or clarification on this issue).

Right of Entry

The Head of College or their nominee (which includes cleaning staff and external maintenance staff) has a right of entry to all areas of a cottage including bedrooms, at any time without notice, in order to: attend to maintenance or service requirements, conduct health and safety inspections, to clean rooms and conduct cleaning inspections, or at any other time as deemed necessary by the Head of College or nominee.

Room occupancy

Rooms at St Martin's are single occupancy with a King single bed provided.

Security

Security is everyone's responsibility. Bedroom doors should be locked at night, and also when the resident is out of the room. During holiday periods unlocked bedroom doors will be locked by staff. Exterior doors to the buildings must be kept always closed. Any interference with the automatic locking of electronic doors to cottages will result in exclusion from the College. Students must not loan cards or keys to other people to allow access. Students gaining access or attempting to gain access through windows will be found to be in breach of the College Regulations and will be automatically placed on Level 2 of the College Discipline Processes.

Smoking

All buildings are non-smoking areas - Smoking inside is prohibited. Smoking outside cottages must be away from open windows and where there is no pedestrian traffic. The University policy on smoking applies to all areas of the Halls of Residence (as defined within the CSU General Regulations) and includes evidence of smoking – eg. odour, ash, butts, *etc.* All residential areas, including St Martin's College are included as prohibited areas for smoking.

The use of a smoking device, known as a "hookah" or "shisha" or vapes (or equivalent products) is also prohibited within the College and immediate surrounds. The preparation of articles/items (eg. coals, embers, *etc*) for use within a device such as the "hookah" is expressly prohibited within St Martin's College and immediate surrounds.

Social Media

Students are expected to abide by CSU's Social Media Guidelines Policy. Inappropriate use of social media will constitute a breach of College Regulations and students breaching this policy will be subject to discipline processes.



State and Federal Laws

The College is subject to State and Federal laws. Police will enforce the laws of the State or Commonwealth as appropriate in the College.

University By-laws, Rules, Regulations and Policies

The College is subject to the University's By-laws, rules, regulations and policies. These will be enforced in addition to the College's rules and regulations. Visitors

Each resident is responsible for the conduct of his or her visitors at all times, this includes the responsibility to pay for any damage caused by a visitor. Visitors must not disturb the residents or College staff. Visitors are not permitted between 10pm and 10am without permission of the Head of College.

No visitor may be left unattended in a cottage or student room – if the host student is not in the cottage, then the visitor must leave the cottage.

Wilful Damage, Vandalism, Graffiti

Any form of graffiti, vandalism or wilful damage to furniture, tables, cupboards, doors, carpet or any other furnishing or fixture of the College, staff property or other residents' property is prohibited. You are responsible for any damage to your bedroom (other than that resulting from normal wear and tear). An inventory of your room is kept and your room will be inspected on departure. You are responsible for any damages or losses and you will be charged for the repair or replacement of the item/s.

You are also responsible for reimbursement of any damage and for damage caused by your guests.

Work, Health and Safety

The College conducts regular WHS inspections to ensure the safety of staff, students and visitors to the College.

Please note the following safety matters:

- no cords to be left on floors
- no razors to be left in showers
- no double adaptors allowed
- no electrical heaters allowed
- drying racks are not allowed in common room areas
- no flammable liquids or combustibles are allowed in St Martin's College.

Should you identify any hazards around the College please do what you can to safely remove the hazard or contact the Head of College.

Fairfax Centre Conditions of Use



- The Fairfax Centre is the college's central community space where students can meet for recreational and study purposes. Students are welcome to use this space and enjoy what is offered in the Centre.
- Determination of the use of the building lies with the Head of College and should be consistent with supporting the St Martin's College student community. The use must also be consistent with the Christian ethos and philosophy of the College and its Board.
- CSU Students using the Building and Facilities for recreational or study purposes may only do so at the invitation of and in the company of St Martin's College students, or the invitation of the Head of College.
- Students using the building are responsible for cleaning up all rubbish and tidying the building, BBQ and kitchen areas after each use. Failure to do so will result in:
 - > any cleaning costs incurred for each occurrence or
 - > exclusion from use of the recreational and study facilities in extreme cases.
- Hours of use for the building are at the discretion of the Head of College but must not breach College noise rules. Generally, during Semester time, students may access the building at any time using their CSU Student Card.
- To ensure access for a group study project or to sit an exam, the "Study Common" must be booked in advance with St Martin's office staff. These bookings will be displayed on the door and guarantee you access to the space for the time it has been booked. If there are no bookings other residents are welcome to use the Study Common if it is free. Residents with bookings will have precedence.
- The Kitchen is there for the use of students. To guarantee exclusive use you can book in advance through the College office prior to use. At other times residents are welcome to use the kitchen and are required to ensure it is clean when they depart.
- The photocopier in the foyer is only for use of St Martins College staff and students. Student access is by CSU student ID number.
- Unacceptable behaviour is not allowed and those who are inebriated will be asked to leave immediately and will be excluded from further use. Alcohol may be consumed in moderation in the Centre. The RAs and/or Head of College are to be advised in advance prior to any gathering of students where alcohol is consumed.

Activities that have the consumption of alcohol as the prime focus will not be allowed.

- Apart from table tennis, pool table and the games provided, no sporting equipment is to be used in the building without permission of the Head of College.
- Any breach of these rules, or failure to vacate the building at the request of the RAs or Head of College, may result in immediate exclusion from use of the building and possible exclusion from the College.

Discipline should not be seen as a negative. In any community the concepts of justice, law and authority are essential for the good order of that society. It is a community based on Christian values which is the over-riding motive for discipline. If a College or University rule or regulation is broken, disciplinary action will occur. Generally, this disciplinary action will consist of a fine (not exceeding \$500), reimbursement of any damage or cleaning costs – in extreme cases it may mean exclusion from the College and a suspension of a student's degree program.

If a State and/or Federal Law is broken the matter will immediately be reported to the Police in addition to the College disciplinary process.

The College Board retains the right to ask a person to vacate their room immediately if the behaviour of the person compromises the welfare and safety of other residents, visitors and/or College staff.

A student whose behaviour consistently works against the interests of the College community and breaches College standards will be asked to leave the College.

Students have the right of appeal against any disciplinary action. This appeal must be made in writing to the College Disciplinary Committee and must be received within seven days of receiving written notice of disciplinary action.

Student Disciplinary Committee

The College has a Student Disciplinary Committee that is kept informed of breaches of regulations. Students may be asked to face the Committee as part of the disciplinary process. The Committee consists of two College Board Members and the Head of College.

NSW Police MOU

CSU has a Memorandum of Understanding with the Riverina Police. Senior Police are assigned to work in consultation with Heads of Residences and the Campus Manager in relation to criminal offences or matters that effect the safety and security of residents that come under the notice of NSW Police.

These are examples of activities not permitted in the College, however, common sense and hopefully maturity should prevail in use of the building.
